Shift Differentials: No Shift Differentials

Work Week: Sunday – Saturday

Overtime Rate(s): 1.3x the normal hourly rate for hours worked over forty hours in a week for all SCA Covered Employees.

For California – Beyond eight hours in an workday or more than six days in any workweek: 1.6 times the employee’s regular rate of pay for all hours worked in excess of eight hours up to and including 12 hours in any workday, and for the first eight hours worked on the seventh consecutive day of work in a workweek; and 1.3 times the employee’s regular rate of pay for all hours worked in excess of 12 hours in any workday and for all hours worked in excess of eight of the seventh consecutive day of work in a workweek.

Holiday Rate(s): 1.3x (times) the regular hourly rate for all Federal Holidays only when worked.

On-Call Rate(s): \$8 per hour for SCA covered positions while in “on-call” status. The provider must carry a beeper or cell phone and remain within a 30 min/mile radius of the facility (or an agreed to radius by the task ordering facility). Phone consultations are included.

Call Back Rate(s): If the placement is called back to the facility the regular hourly base rate (task order) will be charged unless overtime is incurred. 2 hour minimum.
